
Family Investment

Individuals receiving Temporary Cash Assistance are required to seek work. Our Work Opportunities staff assist in developing workplace skills and finding employment

- Placed 42 TCA recipients in jobs. Four were full time and average starting salary was \$9.65
- 31 local employers hired our customers
- Transportation was provided to 64 customers through our partnership with Delmarva Community Transit
- We saw a 17% decrease in our TCA caseload. Employability U total recipients from July 1, 2016 to June 30, 2017 was 142.
- Our Work Participation Rate was 27%
- Case Compliance- SNAP and Expedited SNAP cases were completed on time 96% of the time. TCA cases were completed on time 96% of the time except for September (95.1%).



- Our vacancy rate for the year totaled 17.5%



Adult Protective Services

- 100 % of confirmed cases had no repeat findings.
- 85.3% of Adult Protective Services cases were able to remain in the community in the least restrictive environment.

Project HOME

- 100% of residents were maintained in a stable placement.
- 100% of Project C.A.R.E. HOME residents had no confirmed cases of abuse / neglect / explo<mark>itati</mark>on within the last six months.
- 100% of HIV Case Management customers remained in their own home.
- 100% of HOPWA recipients maintained stable housing and income.

Senior Care

Child Support

Child Support Accomplishments

- Provided case maintenance and management for 2309 active cases through the reporting period.
- Disbursed a total of \$4,273,300 in payments.
- Current support distributions totaled \$3,126,204.
- Arrears payments received totaled \$1,147,096.
- Paternity was established for 1,762 Dorchester County residents.
- Court Orders were established for 2,168 Dorchester County residents.
- Improved in (3 of 4) federal performance criteria during FY17.
- Continued our partnership with the midshore RISE Program, which is hosted and organized by Caroline County DSS, to support non-custodial parents with job search, employment services, job retention services, transportation, education and job certification needs. There were 67 Dorchester County Non-Custodial Parents served this past fiscal year.
- Began working towards the implementation of a non-cash payment system at our office.
